The increase has been allocated as follows: Base Wage \$0.41, Special Assessment Fund \$0.13 Health & Welfare Insurance \$0.25, Pension \$0.09, Annuity Fund \$0.40, Apprenticeship \$0.10 and Labor/Management Productivity & Training \$0.02.

Note: The increase is effective with your company's first full payroll period that begins on or after June 1, 2015.
