

Flint Residents Asked To Flush Out Lead By Running Taps Mlive

April 16, 2016

The EPA and MDEQ and the City of Flint issued a joint recommendation to the citizens of Flint to turn on bathroom, tub and kitchen taps and run them full-on for five minutes a day at no cost. This action is intended to help remove particulate lead that continues to contribute to spiked lead levels throughout Flint.
