TO: ALL MICHIGAN INFRASTRUCTURE AND TRANSPORTATION CONTRACTORS (SECTION D2)

The 2013-2021 labor contract with the Michigan Regional Council of Carpenters provides for a June 1, 2019 Gross Wage increase for Southeast Michigan of \$1.00/hr. effective June 1, 2019. The increase has been allocated as follows: Base Wage \$0.70 and Apprenticeship \$0.30.

EFFECTIVE THE FIRST FULL PAYROLL PERIOD COMMENCING ON OR AFTER JUNE 1, 2019 THROUGH MAY 31, 2020
