TO: ALL MICHIGAN INFRASTRUCTURE AND TRANSPORTATION CONTRACTORS (SECTION D2) SOUTHEASTERN MI

The 2021-2026 labor contract with the Michigan Regional Council of Carpenters provides for a June 1, 2021 Gross Wage increase for Southeast Michigan of \$1.72/hr. effective June 1, 2021. The increase has been allocated as follows: Base Wage \$1.43, U.B.C. Per Cap \$0.02, U.B.C. Training \$0.02, Health & Welfare Supplemental \$0.10, and Annuity \$0.15.

EFFECTIVE THE FIRST FULL PAYROLL PERIOD COMMENCING ON OR AFTER JUNE 1, 2021 THROUGH MAY 31, 2022
