**TO: ALL MICHIGAN INFRASTRUCTURE AND TRANSPORTATION CONTRACTORS (SECTION D2)
SOUTHEASTERN MI**

The 2021-2026 labor contract with the Michigan Regional Council of Carpenters provides for a June 1, 2022 Gross Wage increase for Southeast Michigan of \$1.71/hr. effective June 1, 2022. The increase has been allocated as follows: Base Wage \$1.39, U.B.C. Per Cap \$0.01, U.B.C. Training \$0.01, Health & Welfare Supplemental \$0.10, Annuity \$0.15, and U.B.C Pile Driver Labor Management \$0.05.

EFFECTIVE THE FIRST FULL PAYROLL PERIOD
COMMENCING ON OR AFTER JUNE 1, 2022 THROUGH MAY 31, 2023

Insurance amount of \$8.00 is \$7.05 for Health & Welfare Insurance and \$0.95 for the Health & Welfare Supplemental Fund. Special Assessment of \$0.40 includes \$0.20 for the Building Fund.
