**TO: ALL MICHIGAN INFRASTRUCTURE AND TRANSPORTATION CONTRACTORS
(EXCLUDING SOUTHEASTERN MI)**

The 2021-2026 labor contract with the Michigan Regional Council of Carpenters provides for a June 1, 2024 total package increase for Outstate Michigan of \$2.00/hr. effective June 1, 2024. The increase has been allocated as follows: Base Wage \$1.98, U.B.C. Per Cap \$0.01, and U.B.C. Training \$0.01.

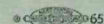
