TO: ALL MICHIGAN INFRASTRUCTURE AND TRANSPORTATION CONTRACTORS (EXCLUDING SOUTHEASTERN MI)

The 2021-2026 labor contract with the Michigan Regional Council of Carpenters provides for a June 1, 2025 total package increase for Outstate Michigan of \$2.00/hr. effective June 1, 2025. The increase has been allocated as follows: Base Wage \$2.00.

Special Assessment of \$0.40 includes \$0.20 for the Facilities Fund.
